BULLER This court has found reasonable cause to believe that such offense was committed and that the defendant committed it.

Justice of the Peace/Magistrate

Victim and arrestee had an intimate and romantic relationship. Between January 1st 2016 and September 09, 2016 the arrestee assaulted/strangled the victim on at least four occasions. The victim received bruises, scratches and bloody noses during these assaults. Victim stated during each assault she was strangled by arrestee and her airway was impeded.

January 2016: Arrestee gets upset over needing a cell phone. Arrestee grabbed the victim by the neck pushing her against the wall. Arrestee strangled the victim for 15-20 seconds impeding the victim's airway.

Summer 2016: Arrestee gets upset at the victim, arrestee physically assaults the victim. Arrestee grabs victim by the neck, impeding her airway. Victim stated she almost passed out. Victim received bruises and scratches to her sides, neck and chest.

Summer 2016: Arrestee saw a text on victim's phone. Arrestee became upset and told victim to get in the shower. Arrestee slapped victim in the head causing victim to hit her head on the shower wall. Arrestee hit the victim on the nose causing it to bleed and victims face to swell. Victim stated arrestee strangled her on this occasion as well, impeded airway. Victim had injuries consistent with this.

September 1st 2016: Victim arrives home at approximately 11:30 pm from work. Arrestee is waiting outside victim's front door. Arrestee grabs the flesh of victim's back and twists telling the victim to go in the apartment. Victim screams out in pain. Arrestee grabbed victim by the hair and slapped her in the face causing her nose to bleed. Arrestee strangled victim impeding her airway. Victim had injuries consistent with the assault.

Victim took pictures of injuries from incidents which she provided to police.
